**Title** Generally applicable transcriptome-wide analysis of translational efficiency using anota2seq

**Description** anota2seq provides analysis of translational efficiency and differential expression analysis for polysome-profiling and ribosome-profiling studies (two or more sample classes) quantified by RNA sequencing or DNA-microarray. Polysome-profiling and ribosome-profiling typically generate data for two RNA sources; translated mRNA and total mRNA. Analysis of differential expression is used to estimate changes within each RNA source (i.e. translated mRNA or total mRNA). Analysis of translational efficiency aims to identify changes in translation efficiency leading to altered protein levels that are independent of total mRNA levels (i.e. changes in translated mRNA that are independent of levels of total mRNA) or buffering, a mechanism regulating translational efficiency so that protein levels remain constant despite fluctuating total mRNA levels (i.e. changes in total mRNA that are independent of levels of translated mRNA). anota2seq applies analysis of partial variance and the random variance model to fulfill these tasks.

Description

These functions generate graphical outputs aiming to provide an overview of the extents of different regulatory modes of gene expression. The graphical outputs consist of:

1. For all selected contrasts, P-value and FDR density plots indicating the distribution of P-values and FDRs for all analyzes found in the Anota2seqDataSet object.
2. Fold change plots where total mRNA log2FC is compared to translated mRNA (e.g. polysome-associated mRNA or RPF) log2FC (for all selected contrasts).
3. Per identifier and per treatment fitted regression curves between total and translated mRNA for all samples which helps evaluating regulation of single identifiers.

**Arguments**

<b>object</b>	An object of class Anota2seqDataSet. Should contain output of the anota2seqAnalyze function. To visualize significant identifiers in the fold change plot (anota2seqPlotFC) and for regression plots (anota2seqPlotGenes), the object should also contain the output of anota2seqSelSigGenes and/or anota2seqRegModes (see Details).
<b>visualizeRegModes</b>	Can be set to "all" (default, genes which were selected by <a href="#">anota2seqSelSigGenes</a> are colored according to their allocated regulatory mode (change in mRNA abundance or change in translational efficiency leading to altered protein levels or buffering), "none" (no colors), "translation" (only identifiers regulated by change in translational efficiency leading to altered protein levels are colored), "buffering" (only identifiers regulated by change in translational efficiency leading to buffering are colored). The object will be required to contain different outputs depending on the value given to this parameter (see Details).
<b>selContrast</b>	Which contrast(s) should be considered? Descriptions of the contrasts can be found in the output from the anota2seqAnalyze object in the usedContrasts slot. Indicate the contrast(s) by a numeric vector of the column number(s).
<b>contrastName</b>	Custom name annotation for the selected contrast(s). Provide a character name for each selected contrast, this name will be used as plot title in the anota2seqPlotPvalues plots or as xlab and ylab annotation in the anota2seqPlotFC plots.
<b>fileStem</b>	if plotToFile is TRUE, this stem will be added in front of the output filename(s).

<code>plotToFile</code>	Boolean. If set to TRUE (default) the function will output the plot as a PDF file. If set to FALSE plots will be plotted to the R default graphics device.
<code>myXlim</code>	Specify the x-axis limits used for the scatterplots(s) in the <code>anota2seqPlotFC</code> function. Default is NULL.
<code>myYlim</code>	Specify the y-axis limits used for the scatterplot(s) in the <code>anota2seqPlotFC</code> function. Default is NULL
<code>...</code>	Graphical parameters that are passed to the <code>par()</code> function.
<code>useRVM</code>	Should the density plot be performed on RVM p-values/FDR (default) or no-RVM p-values/FDR?
<code>myBw</code>	Smoothing bandwidth parameter for used in the <code>stats::density</code> function. Within one plot, the same bandwidth will be used for all density curves.
<code>analysis</code>	For which analysis should <code>anota2seqPlotGenes</code> be performed. Can be set to "translation" or "buffering".
<code>geneNames</code>	When <code>anota2seqPlotGenes</code> performs the individual gene plots they will be named by the original row names supplied to the <code>anota2seqAnalyze</code> function. <code>geneNames</code> allows the user to add additional names when plotting to e.g. include gene symbols. Input is a matrix with one column where the original row names match the row names of the input matrix and the desired new names are given in column 1. Default is NULL i.e. no additional names.

## Details

`anota2seqPlotFC`: if `visualizeRegModes` is set to "none", the `Anota2seqDataSet` object is only required to contain an output of `anota2seqAnalyze`. If `visualizeRegModes` is set to "translation" or "buffering", the object should contain the output of `anota2seqAnalyze` and `anota2seqSelSigGenes` for the corresponding analysis. Finally, if `visualizeRegModes` is set to "all" (default), `anota2seqRegModes` should have been called on the `Anota2seqDataSet` object so that identifiers can be colored according to the three regulatory modes (i.e. change in mRNA abundance or change in translational efficiency leading to altered protein levels or buffering).

`anota2seqPlotGenes`: requires an `Anota2seqDataSet` object containing the output of [anota2seqAnalyze](#) and [anota2seqSelSigGenes](#) for translation and/or buffering. In the graphical output of `anota2seqPlotGenes`, the results for each significant gene is displayed on a separate row. The first graph shows all samples and per treatment regression lines using the common slope with different colors for each treatment. The magnitude of the common slope is indicated. The second graph shows key statistics for the identifier without the RVM model for all contrasts analyzed when running `anota2seqAnalyze`. The third graph is similar to the second but with RVM statistics instead.

## Value

No value is returned. These functions generate a graphical outputs as described above.

## Description

Analysis of treatment effects for translated mRNA (polysome-associated mRNA or RPFs; i.e. the "P" samples in the SummarizedExperiment annotation or the samples in the dataP matrix) or total mRNA (i.e. the "T" samples in the SummarizedExperiment annotation or the samples in the dataT matrix); and/or identification of changes in translational efficiency leading to altered protein levels or buffering.

Anota2seqDataSet	An object of class Anota2seqDataSet
contrasts	If NULL (default), the contrasts will be created automatically and may not correspond to those of interest. It is therefore possible to use custom contrasts using this parameter. The input should be a matrix with row names corresponding to treatments (i.e. those in phenoVec or the treatment column of the SummarizedExperiment annotation) and columns corresponding to the different contrasts of interest (see Details section and examples for additional information on how to set up a custom contrast matrix).

correctionMethod	Correction for multiple testing method. This parameter can be set to "Bonferroni", "Holm", "Hochberg", "SidakSS", "SidakSD", "BH", "BY", "ABH" or "TSBH" as implemented in the multtest package or "qvalue" as implemented in the qvalue package. Default is "BH".
useProgBar	Should the progress bar be shown? Default is TRUE, show progress bar.
fileStem	Stem for output file name (see Value section). Default is "ANOTA2SEQ".
analysis	Specification of which analysis should be performed. Can be set to "translated mRNA", "total mRNA", "translation", "buffering" or any combination of these. If set to translated mRNA or total mRNA, the function will perform differential expression analysis (based on default or supplied contrasts) for the specified mRNA source. If set to "translation", analysis of changes in translational efficiency leading to altered protein levels will be performed. If set to "buffering", analysis of changes in translational efficiency leading to buffering will be performed. Default is c("translated mRNA", "total mRNA", "translation", "buffering") i.e. all analyzes are performed.

## Details

The function performs APV on two or more sample categories according to default contrasts or contrasts supplied by the user. The Random Variance Model (RVM) will be applied but the results without RVM will also be available in the output.

More details about setting a contrast matrix: By default (i.e. with contrasts = NULL), the order of the sample classes which are used to calculate differences between treatments will be in alphabetical order. To change the directionality of the contrasts (e.g. treatment b vs treatment a instead of treatment a vs treatment b) or to generate a custom set of contrasts when more than 2 treatments are included, a contrast matrix can be supplied to the "contrasts" parameter described above. The row names should be specified as indicated above. The contrasts are coded by using e.g. -1 for group a, 0 for group b and 1 for group c to compare group a and c; -2 for group a, 1 for group b and 1 for group c to compare group a to b & c. Each column of the contrast matrix should sum to 0 and to analyze orthogonal contrasts the products of all pairwise rows should sum to 0. The results in the Anota2seqDataSet object will follow the order of the contrasts (i.e. results for e.g. contrast 1 will correspond to the contrasts specified in column 1 of the contrast matrix).

## Value

An Anota2seqDataSet. anota2seqAnalyze saves its output data in the 'translatedmRNA', 'totalmRNA', 'translation' and 'buffering' slots of the Anota2seqDataSet output object when analysis is set to "translated mRNA", "total mRNA", "translation" and "buffering" respectively. This output contains statistics from the applied APV model and can be accessed using [anota2seqGetOutput](#) (See [?anota2seqGetOutput](#) for a detailed description). Additionally, [anota2seqAnalyze](#) saves fold changes and translational efficiency (TE) scores in the 'deltaData' slot of the Anota2seqDataSet object. (See [?anota2seqGetDeltaData](#) for a detailed description of deltaData).

[anota2seqAnalyze](#) creates a plot showing the fit of the inverse gamma distribution used in RVM (i.e. a similar output as compared to that from anota2seqPerformQC) for each contrast.

## Description

A S4 class to store and collect output from the anota2seq workflow.

## Details

The Anota2seqDataSet will be used to collect outputs of the [anota2seqPerformQC](#), [anota2seqResidOutlierTest](#), [anota2seqSelSigGenes](#) and [anota2seqRegModes](#) functions. The results that are collected in the Anota2seqDataSet can be accessed using the anota2seq.get methods. Furthermore show() gives an overview of the stored objects in the Anota2seqDataSet.

## Slots

**dataT** a matrix containing normalized data for total mRNA. Can be accessed using [anota2seqGetNormalizedData](#).

**dataP** a matrix containing normalized data for translated mRNA. Can be accessed using [anota2seqGetNormalizedData](#).

**phenoVec** a vector describing the sample class for each column of dataT and dataP. Can be accessed using [anota2seqGetCovariates](#).

**batchVec** an optional vector describing a batch class for each column of dataT and dataP. Can be accessed using [anota2seqGetCovariates](#).

**contrasts** a matrix describing the contrasts to be used in the analysis. Can be accessed using [anota2seqGetContrasts](#).

**qualityControl** after running anota2seqPerformQC, its output will be saved in this slot of the Anota2seqDataSet object. Can be accessed using [anota2seqGetQualityControl](#).

**residOutlierTest** after running anota2seqResidOutlierTest, its output will be saved in this slot of the Anota2seqDataSet object. Can be accessed using [anota2seqGetResidOutlierTest](#).

**translatedmRNA** after running [anota2seqAnalyze](#) with analysis parameter set to "translated mRNA" (or [anota2seqRun](#)), its output (results of the differential expression analysis) will be saved in this slot of the Anota2seqDataSet object. Can be accessed using [anota2seqGetOutput](#) with analysis = "translated mRNA" and output = "full".

**totalmRNA** after running [anota2seqAnalyze](#) with analysis parameter set to "total mRNA" (or [anota2seqRun](#)), its output (results of the differential expression analysis) will be saved in this slot of the Anota2seqDataSet object. Can be accessed using [anota2seqGetOutput](#) with analysis = "total mRNA" and output = "full".

**translation** after running [anota2seqAnalyze](#) with analysis parameter set to "translation" (or [anota2seqRun](#)), its output (results of the analysis of changes in translational efficiency leading to altered protein levels) will be saved in this slot of the Anota2seqDataSet object. Can be accessed using [anota2seqGetOutput](#) with analysis = "translation" and output = "full".



- buffering** after running [anota2seqAnalyze](#) with analysis parameter set to "buffering" (or [anota2seqRun](#)), its output (results of the analysis of changes in translational efficiency leading to buffering) will be saved in this slot of the `Anota2seqDataSet` object. Can be accessed using [anota2seqGetOutput](#) with analysis = "buffering" and output = "full".
- selectedTranslatedmRNA** after running [anota2seqSelSigGenes](#) with analysis parameter set to "translated mRNA" (or [anota2seqRun](#)), its output (results of the differential expression analysis on selected genes based on user defined thresholds in `anota2seqSelSigGenes`) will be saved in this slot of the `Anota2seqDataSet` object. Can be accessed using [anota2seqGetOutput](#) with analysis = "translated mRNA" and output = "selected".
- selectedTotalmRNA** after running [anota2seqSelSigGenes](#) with analysis parameter set to "total mRNA" (or [anota2seqRun](#)), its output (results of the differential expression analysis on selected genes based on user defined thresholds in `anota2seqSelSigGenes`) will be saved in this slot of the `Anota2seqDataSet` object. Can be accessed using [anota2seqGetOutput](#) with analysis = "total mRNA" and output = "selected".
- selectedTranslation** after running [anota2seqSelSigGenes](#) with analysis parameter set to "translation" (or [anota2seqRun](#)), its output (results of the analysis of changes in translational efficiency leading to altered protein levels on selected genes) will be saved in this slot of the `Anota2seqDataSet` object. Can be accessed using [anota2seqGetOutput](#) with analysis = "translation" and output = "selected".
- selectedBuffering** after running [anota2seqSelSigGenes](#) with analysis parameter set to "buffering" (or [anota2seqRun](#)), its output (results of the analysis of changes in translational efficiency leading to buffering on selected genes) will be saved in this slot of the `Anota2seqDataSet` object. Can be accessed using [anota2seqGetOutput](#) with analysis = "buffering" and output = "selected".
- mRNAAbundance** after running [anota2seqRegModes](#) (or [anota2seqRun](#)), its output will be saved in this slot of the `Anota2seqDataSet` object. This output will contains results of the differential expression analysis on genes selected to be considered as regulated by mRNA abundance. The definition of regulation by mRNA abundance can be based on results from total mRNA, translated mRNA or both (this is set by the user on parameter `mRNASelect` in `anota2seqRegModes`). Statistics results from mRNA type(s) considered in this definition will be saved in this slot. Can be accessed using [anota2seqGetOutput](#) with analysis = "mRNA abundance" and output = "selected".
- deltaData** after running [anota2seqAnalyze](#), an additional output called `deltaData` will be stored in the `Anota2seqDataSet`. `deltaData` is a list of matrices with one `deltaData` matrix for each contrast. For each matrix the rows correspond to the mRNA in the dataset and has the following columns: `deltaP`, `deltaT`, `deltaPT` and `deltaTP`. `deltaP` is translated mRNA fold change, `deltaT` is the total mRNA fold change, `deltaPT` is the within contrast difference difference of the log ratios with translated mRNA in the nominator and total mRNA in the denominator (`deltaPT` is commonly called TE score = Translational efficiency score) and `deltaTP` is the within contrast difference of the log ratios with total mRNA in the nominator and translated mRNA in the denominator.

## Description

Functions used to create an Anota2seqDataSet S4 object from user input. This object will be used to collect data and results from all steps of the anota2seq workflow and is initiated using one of the 2 available constructors: `anota2seqDataSetFromMatrix` (use when the input data is provided as a set of custom vectors and matrices) or `anota2seqDataSetFromSE` (use when the input is of the class `SummarizedExperiment`).

## Arguments

dataP	This parameter is used if selecting to initiate the Anota2seqDataSet using custom vectors and matrices, and the <code>anota2seqDataSetFromMatrix</code> function. A matrix containing data for translated mRNA (e.g. polysome-associated mRNA or RPF). Rows must correspond to identifiers (only non-numerical row names are allowed) and columns to samples.
dataT	This parameter is used if selecting to initiate the Anota2seqDataSet using custom vectors and matrices, and the <code>anota2seqDataSetFromMatrix</code> function. A matrix containing data for total mRNA. Rows must correspond to identifiers (only non-numerical row names are allowed) and columns to samples.
phenoVec	This parameter is used if selecting to initiate the Anota2seqDataSet using custom vectors and matrices, and the <code>anota2seqDataSetFromMatrix</code> function. A vector describing the treatments (each treatment should have a unique identifier). Note that dataT, dataP and phenoVec have to have the same sample order such that e.g. column 1 in dataP is the translated mRNA for a sample, column 1 in dataT is the total mRNA data and position 1 in phenoVec describes the sample treatment.
batchVec	This parameter is used if selecting to initiate the Anota2seqDataSet using custom vectors and matrices, and the <code>anota2seqDataSetFromMatrix</code> function. A vector describing annotation of the samples according to their batch (each batch should have a unique identifier). Note that dataT, dataP and batchVec have to have the same sample order such that e.g. column 1 in dataP is the polysome association data for a sample, column 1 in dataT is the total mRNA data and position 1 in batchVec describes the batch identity.
dataType	This parameter is used when selecting to initiate the Anota2seqDataSet using the <code>anota2seqDataSetFromMatrix</code> or the <code>anota2seqDataSetFromSE</code> functions.

	Specify the platform on which data were acquired. Can be set to either "microarray" (i.e. already on a continuous log transformed scale) or "RNAseq" (i.e. count data). For pre-normalized RNAseq data that is on a continuous log scale, "microarray" or "RNAseq" in combination with setting the parameter "normalize" to FALSE could be used.

This column will also be used to order columns of translated and total RNA data.
- "batch": under this optional column the batch identity of each sample is indicated (depending on whether the downstream analysis will include a batch parameter or not). A common batch used in downstream analysis is replicate but any other batch that does not overlap with analyzed treatments can be used. Each batch must be indicated by a unique identifier (i.e. not used by any other batch).

**assayNum** This parameter is used if selecting to initiate the Anota2seqDataSet using a SummarizedExperiment object and the `anota2seqDataSetFromSE` function and should specify the assay position (retrieved by "assays(se)") containing the expression data for analysis. By default, the first assay will be used.

## Details

These functions initiate an Anota2seqDataSet and provide possibilities to filter, transform and normalize the data. The input can be either of the SummarizedExperiment class including the annotation as outlined above or as a set of matrices of vectors that together contain the same information.

If raw RNAseq data (or other count data) is provided, gene filtering for genes with 0 counts in at least one sample (optional) can be performed followed by normalization and transformation. Transformation algorithms that are available are rlog (DESeq2 package) and TMM-log2 (TMM normalization using the edgeR package followed by log2 counts per million computation using the voom function of the limma package). The relative performance of these methods have been described elsewhere.

A rare error can occur when data within translated mRNA (polysome-associated mRNA or RPF) or total mRNA data from any gene and any treatment has no variance. Users can use the `varCutOff` parameter to perform filtering based on variance per mRNA source (i.e. polysome-associated mRNA (RPFs) or total mRNA) and treatment. This will eliminate this error which is due to that statistics cannot be calculated in the absence of variance.

Default is "BH".
<code>useDfb</code>	Should <code>anota2seq</code> assess the occurrence of highly influential data points (TRUE/FALSE with default TRUE).
<code>useDfbSim</code>	The random occurrence of <code>dfbetas</code> can be simulated. Default is TRUE. FALSE represses simulation which reduces computation time but makes interpretation of the <code>dfbetas</code> difficult.
<code>nDfbSimData</code>	If <code>useDfbSim</code> is TRUE the user can select the number of sampling that will be performed per step (10 steps with different correlations between the polysome association and the total mRNA level). Default is 2000.
<code>useRVM</code>	The Random Variance Model (RVM) can be used for the omnibus treatment analysis. In this case the effect of RVM on the distribution of the interaction significances needs to be tested as well. TRUE/FALSE where default (TRUE) leads to calculation of RVM p-values for both omnibus interactions and omnibus treatment effects.
<code>onlyGroup</code>	It is possible to suppress the omnibus interaction analysis and only perform the omnibus treatment analysis. TRUE/FALSE with default FALSE (analyze both interactions and treatment effects.)

## Details

The `anota2seqPerformQC` performs the basic quality control of the data set. Two levels of quality control are assessed, both of which need to show good performance for valid application of `anota2seq`. First, `anota2seq` assumes that there are no interactions (for slopes). The output for this analysis is both a density plot and a histogram plot of both the raw p-values and the p-values adjusted by the selected multiple correction method (if RVM was used, the second page shows the

same presentation using RVM p-values). anota2seq requires a uniform distribution of the raw interaction p-values for valid analysis of changes in translational efficiency affecting protein levels and buffering. anota2seq also assesses if there are more data points with high influence on the regression analyzes than would be expected by chance. anota2seq identifies influential data points as data points that influence the slope of the regression using standardized dfbeta (dfbetas). The function also performs an omnibus treatment effect test if there are more than 2 treatments. It is possible to use RVM for the omnibus treatment statistics. If RVM is used, it is necessary to verify that the interaction RVM p-values also follow the expected NULL distribution.

### Value

An Anota2seqDataSet. anota2seqPerformQC saves its output data in the 'qualityControl' slot of the Anota2seqDataSet, see [anota2seqGetQualityControl](#) for a detailed description of this output.

anota2seqPerformQC also generates several graphical outputs. One output ("ANOTA2SEQ\_interaction\_p\_distribution.pdf") shows the distribution of p-values and adjusted p-values for the omnibus interaction (both using densities and histograms). The second page of the pdf displays the same plots but for the RVM statistics if RVM is used. One output ("ANOTA2SEQ\_simulated\_vs\_obtained\_dfbs.pdf") shows bar graphs of the frequencies of outlier dfbetas using different dfbetas thresholds. If the simulation was enabled (recommended) these are compared to the frequencies from the random data set. One optional graphical output shows the gene by gene regressions with the sample classes indicated. In the case where RVM is used, a Q-Q plot and a comparison of the CDF of the variances to the theoretical CDF of the F-distribution is generated (output as "ANOTA2SEQ\_rvm\_fit\_for\_....jpg") for both the omnibus sample class and the omnibus interaction test.

## Description

Polysome or ribosome profiling allows the user to distinguish between three regulatory modes of gene expression: changes mRNA abundance or translational efficiency leading to altered protein levels or buffering (see references). Following a complete analysis, this function categorizes each identifier into one of these regulatory patterns.

## Details

The regulatory modes are given a priority order. First, changes in translational efficiency leading to altered protein levels is considered such that if an identifier passed filtering for this analysis it will be allocated to the translation group. Identifiers that did not pass those thresholds are then considered for belonging to the mRNA abundance group. For this step, the user can decide to base inclusion into the abundance group based on results from analysis of translated mRNA (e.g. polysome-associated mRNA or RPF), total mRNA or both (see below). Finally, the remaining identifiers can be assessed for belonging to the translational buffering group.

An mRNA abundance identifier can be defined based on analysis of translated mRNA (e.g. polysome associated mRNA or or RPF) and total mRNA (and also assuring that fold changes follow the same direction). To perform such analysis, `mRNASelect` should be set to `c(TRUE, TRUE)`. Alternatively one can identify mRNA abundance identifiers based on analysis of only translated mRNA (e.g. polysome-associated mRNA or RPFs; `mRNASelect = c(TRUE, FALSE)`) or only total mRNA (`mRNASelect = c(FALSE, TRUE)`).

## Value

An `Anota2seqDataSet`. `anota2seqRegModes` adds a column specifying the regulatory modes of each significant identifier to the dataframe in the `'selectedTranslatedmRNA'`, `'selectedTotalmRNA'`, `'selectedTranslation'` and `'selectedBuffering'` slots of the `Anota2seqDataSet`. It also saves the output of `anota2seqSelSigGenes` for identifier regulated by mRNA abundance in the `mRNAAbundance` slot of the object. See [anota2seqGetOutput](#) for a detailed description of these outputs.

## Description

One assumption when performing APV is that the residuals from the regressions are normally distributed. anota2seq assesses this by comparing the Q-Q plots of the residuals to envelopes derived by sampling from the normal distribution.

**Details**

The anota2seqResidOutlierTest function assesses whether the residuals from the per identifier linear regressions of translated mRNA level~total mRNA level+treatment are normally distributed. anota2seq generates normal Q-Q plots of the residuals. If the residuals are normally distributed, the data quantiles will form a straight diagonal line from bottom left to top right. Because there are typically relatively few data points, anota2seq calculates "envelopes" based on a set of samplings from the normal distribution using the same number of data points as for the true data *Venables, Ripley*. To enable a comparison both the actual and the sampled data are centered (mean=0) and scaled (sd=1). The data (both true and sampled) are then sorted and the true sample is compared to the envelopes of the sampled data at each sort position. The result is presented as a Q-Q plot of the true data where the envelopes of the sampled data are indicated. If there are 99 samplings we expect that 1/100 values to be outside the envelopes obtained from the samplings. Thus it is possible to assess

if approximately the expected number of outlier residuals are obtained. The result is presented as both a graphical output and an output object.

### Value

An Anota2seqDataSet. anota2seqResidOutlierTest saves its output data in the 'residOutlierTest' slot of the Anota2seqDataSet, see [anota2seqGetResidOutlierTest](#) for a detailed description of this output.

anota2seqResidOutlierTest also generates a graphical output ("ANOTA2SEQ\_residual\_distribution\_summary.pdf") showing the Q-Q plots from all genes as well as the envelopes from the sampled data. The obtained percentage of outliers is shown at each rank position and all combined. Optionally, when generateSingleGenePlots is set to TRUE, the function also generates individual plots (stored as "ANOTA2SEQ\_residual\_distributions\_single.pdf") for n genes (set by nGraphs). When residFitPlot is set to TRUE an output comparing the fitted values to the residuals is generated (stored as "ANOTA2SEQ\_residuals\_vs\_fitted.jpeg").

## Description

`anota2seqRun` is a wrapper function running the following steps of the `anota2seq` workflow: assessing model assumptions (by calling `anota2seqPerformQC` and `anota2seqResidOutlierTest`), performing analysis of changes in translational efficiency leading to altered protein levels or buffering; and differential expression of translated mRNA (e.g. polysome-associated mRNA or RPF) and total mRNA (by calling `anota2seqAnalyze` sequentially with analysis parameter set to "translation", "buffering", "translated mRNA", "total mRNA" respectively). ## thresholds

- `maxSlopeTranslation`: The output can be filtered so that identifiers whose identified slopes in analysis of changes in translational efficiency leading to altered protein levels are too large can be excluded. Default is 2 i.e. excludes identifiers with a slope  $> 2$ .
- `minSlopeBuffering`: The output can be filtered so that identifiers whose identified slopes in analysis of changes in translational efficiency leading to buffering are too small can be excluded. Default is -2 i.e. excludes identifiers with a slope  $<(-2)$ .
- `maxSlopeBuffering`: The output can be filtered so that genes whose identified slopes in analysis of changes in translational efficiency leading to buffering are too large can be excluded. Default is 1 i.e. excludes identifiers with a slope  $> 1$ .
- `maxPAdj`: The output can be filtered based on adjusted p-values from the `anota2seq` analysis (i.e. smaller compared to assigned value). If `useRVM` is set to TRUE, filtering will be performed on RVM values, otherwise filtering will be performed on non-RVM values. Multiple testing adjustment method is set by argument `correctionMethod`. Default is 0.15.
- `maxP`: The output can be filtered based on unadjusted p-values from the `anota2seq` analysis (i.e. smaller compared to assigned value). If `useRVM` is set to TRUE, filtering will be performed on RVM values, otherwise filtering will be performed on non-RVM values. Default is NULL, i.e. no filtering.

## Details

At the step of analysis, by default (i.e. with contrasts = NULL) the order of the sample classes which are used to calculate differences between treatments will be in alphabetical order. To change the directionality of the contrasts (e.g. treatment b vs treatment a instead of treatment a vs treatment b) or to generate a custom set of contrasts when more than 2 treatments are included, a contrast matrix can be supplied to the "contrasts" parameter described above. The row names should be specified as indicated above. The contrasts are coded by using e.g. -1 for group a, 0 for group b and 1 for group c to compare group a and c; -2 for group a, 1 for group b and 1 for group c to compare group a to b & c. Each column of the contrast matrix should sum to 0 and to analyze orthogonal contrasts the products of all pairwise rows should sum to 0. The results in the Anota2seqDataSet object will follow the order of the contrasts (i.e. results for e.g. contrast 1 will correspond to the contrasts specified in column 1 of the contrast matrix).

<code>useRVM</code>	If a significance threshold is provided ( <code>maxP</code> or <code>maxPAdj</code> , see below), should the output be filtered on Random Variance Model p-values or on non-RVM p-values? Default is <code>TRUE</code> i.e. RVM p-values.
<code>analysis</code>	A vector of character string(s) specifying which analysis(es) should be considered for filtering. Should be at least one of the following: "translated mRNA", "total mRNA", "translation" or "buffering". By default, filtering will be performed on all available analyzes in the <code>Anota2seqDataSet</code> object.
<code>selIds</code>	The function can consider only a subset of the identifiers from the input data set. For custom selection of identifiers, supply a vector of identifiers (row names from the original data set) to be included. Default is <code>NULL</code> i.e. filtering is performed on all identifiers.
<code>selContrast</code>	Which contrast(s) should be evaluated during the filtering and sorting? <code>maxSlopeTranslation</code>	The output can be filtered so that identifiers whose identified slopes in analysis of changes in translational efficiency leading to altered protein levels are too large can be excluded. Default is <code>NULL</code> i.e. no filtering based on upper

boundary of the slope. To exclude identifiers with e.g. a slope  $>2$ , assign 2 to maxSlopeTranslation. Only applied when analysis is set to "translation".

minSlopeBuffering

The output can be filtered so that identifiers whose identified slopes in analysis of changes in translational efficiency leading to buffering are too small can be excluded. Default is NULL i.e. no filtering based on lower boundary of the slope. To exclude identifiers with e.g. a slope  $<(-2)$ , assign -2 to minSlopeBuffering. Only applied when analysis is set to "buffering".

maxSlopeBuffering

The output can be filtered so that genes whose identified slopes in analysis of changes in translational efficiency leading to buffering are too large can be excluded. Default is NULL i.e. no filtering based on upper boundary of the slope. To exclude identifiers with e.g. a slope  $>1$ , assign 1 to maxSlopeBuffering. Only applied when analysis is set to "buffering".

slopeP

A p-value for the slope being  $<0$  or  $>1$  if the estimate for the slope is  $<0$  or  $>1$  (for translation) and  $<-1$  or  $>0$  if the estimate for the slope is  $<-1$  or  $>0$  (for buffering). This p-value can be used to filter the output based on unrealistic slopes. When set low, fewer identifiers will be disqualified. Default is NULL i.e. no filtering based on slope p-value. Only applied for when analysis is set to "translation" or "buffering".

minEff

The output can be filtered based on minimum effect for inclusion. The value is applied both to negative and positive effects: e.g. a value of 1 will evaluate if the effects are  $>1$  OR  $<(-1)$ . Default is NULL i.e. no filtering based on effect.

maxP

The output can be filtered based on raw p-values from the anota2seq analysis (i.e. smaller compared to assigned value). If useRVM is set to TRUE, filtering will be performed on RVM values, otherwise filtering will be performed on non-RVM values. Default is NULL i.e. no filtering.

maxPAdj

The output can be filtered based on adjusted p-values from the anota2seq analysis (i.e. smaller compared to assigned value). If useRVM is set to TRUE, filtering will be performed on RVM values, otherwise filtering will be performed on non-RVM values. The adjustment method that was used when running anota2seqAnalyze will be evaluated. Default is NULL i.e. no filtering.

selDeltaPT

The output can be filtered based on the mean  $\log_2(\text{translation data (e.g. polysome-associated mRNA)} / \text{total mRNA data})$  between treatments difference. The treatments are defined by the selected contrast. Default is NULL i.e. no filtering. Only applied when analysis is set to "translation".

selDeltaTP

The output can be filtered based on the mean  $\log_2(\text{total mRNA} / \text{translation data (e.g. polysome-associated mRNA)})$  between treatments difference. The treatments are defined by the selected contrast. Default is NULL i.e. no filtering. Only applied when analysis is set to "buffering".

selDeltaP

The output for analysis changes in translational efficiency leading to altered protein levels can be filtered based on the translation data only so that the minimum absolute difference between treatments for translated mRNA data (e.g. polysome-associated mRNA) is used for inclusion. The treatments are defined by the selected contrast. Default is NULL i.e. no filtering. Use when analysis parameter is set to "translation" (i.e. changes in translational efficiency leading to altered protein levels) or "translated mRNA".

selDeltaT	The output for analysis of changes in translational efficiency leading to buffering can be filtered based on the total mRNA data only so that the minimum absolute difference between treatments for buffering is used for inclusion. The treatments are defined by the selected contrast. Default is NULL i.e. no filtering. Use when analysis parameter is set to "buffering" or "total mRNA".
sortBy	The output can be sorted by effect ("Eff"), raw p-value ("p"), raw RVM p-value ("rvnP") or not sorted ("none"). Default is "rvnP" when useRVM is set to TRUE and "p" when useRVM is set to FALSE.

### Value

An Anota2seqDataSet. anota2seqSelSigGenes saves its output data in the 'selectedTranslatedmRNA', 'selectedTotalmRNA', 'selectedTranslation' and 'selectedBuffering' slots of the Anota2seqDataSet when analysis is set to "translated mRNA", "total mRNA", "translation" and "buffering" respectively. This output contains statistics from the applied APV model on selected genes, see [anota2seqGetOutput](#) for a detailed description.

Eight samples were simulated from 2 sample classes ("control" and "treatment"); both total mRNA (anota2seq\_data\_T) and paired translated mRNA (anota2seq\_data\_P) are provided together with a sample class vector (anota2seq\_pheno\_vec).

anota2seq\_data\_T and anota2seq\_data\_P are 2 matrices with 10748 rows and 8 columns simulated to represent raw RNAseq counts from 8 samples (4 replicates of each condition) and 10748 mRNAs. Columns are ordered according to the RNA type pairing i.e. column 1 of anota2seq\_data\_T is from the same sample as column 1 of anota2seq\_data\_P etc.

**Source**

These data originate from the study by *Oertlin et al.* which compared methods for analysis of translomes quantified by RNAseq.
